Five years of free health care for any service-connected condition.

Eligible returning service members have five years from their date of discharge to receive free VA health care for any service-connected condition, including:

- Primary Care
- Counseling
- Dental Care - within 180 days from your date of discharge
- Behavioral Health
- Women's Health
- Physical Therapy
- Prosthetics
- Substance Abuse Treatment
- Sexual Trauma Counseling
- Stress Management
- Urgent Care

VA Healthcare–VISN 4 offers post-9/11 Veterans exceptional, personalized care and help in transitioning and adjusting to civilian life.



M2VA PROGRAM

Our Post 9/11 Military to VA (M2VA) case management program has specialized primary care services, behavioral health treatment, comprehensive screenings, social work care management and other services.



Case managers provide individualized care and confidential, professional guidance to assist returning Servicemembers with navigating VA health care and resources.



VISN 4's transitional patient advocates ensure post-9/11 Veterans understand their benefits and rights and get the health care they need.

COST OF SERVICES

Treatment of conditions that are not related to your military service will be subject to copayments according to your financial eligibility.

Maximum copays are \$50 for an emergency room or specialty care visit, \$15 for primary care visits and \$5, \$8 or \$11 for 30-day prescriptions.

ACTIVE DUTY AND TRICARE

We work with the Department of Defense and TRICARE to treat active duty military personnel who are on medical hold or convalescent leave.

VISN 4 VET CENTERS

Beyond VISN 4's medical centers and outpatient clinics, Veterans can also receive care at one of the network's VA Vet Centers.
